Nature of Claim: The nature of the claim is for severe and permanent personal injuries 2. sustained by claimant, JONATHAN SCHACHTER, and all other damages allowed by statute and case law as a result of the negligence, carelessness, recklessness and gross negligence of THE CITY OF KINGSTON, its agents, servants and/or employees, departments, agencies and those acting under their directions, behest, permission and control in the ownership, operation, management, control and supervision of a certain sidewalk running along the easterly side of West Strand Street at a point at or near the beginning of 98 Dock Street, City of Kingston, County of Ulster and State of New York (see photographs annexed hereto and incorporated herein showing approximate location of the accident). who were traversing said sidewalk, and claimant herein specifically, as to the hazardous and dangerous condition; in violating Department of Transportation Highway Rules and Regulations; in failing to insure that appropriate warnings of the hazardous conditions were transmitted to the public by radio, internet and other channels of communications; in improperly designing the sidewalk; in permitting dangerous material(s) to be applied to make up the composition of the sidewalk which caused the sidewalk to become more dangerous; in failing to properly maintain the sidewalk and in otherwise being careless, reckless and negligent under all of the attendant circumstances. Upon information and belief, respondents had prior notice of the said dangerous and defective conditions in that the conditions existed for such a period of time prior to the happening of the within accident, that the respondent, its agents, servants and or employees, in the exercise of reasonable care and due diligence, knew or should have known that the condition(s) existed thereat and that respondent, its agents, servants and/or employees caused and created said dangerous and hazardous conditions. As a result of the negligence, carelessness and recklessness of the Respondent, its agents, servants and/or employees, departments, agencies and those acting under their directions, behest, permission and control Mr. Schachter suffered serious injuries.

- 3. The time when, the place where and the manner in which the claim arose: Said claim arose on May 8, 2021, at approximately 7:00 p.m. while Claimant, JONATHAN SCHACHTER, who was a lawful pedestrian upon said sidewalk running along the Westerly side of West Strand Street at a point at or near the beginning of 98 Dock Street, City of Kingston, County of Ulster and State of New York. Claimant JONATHAN SCHACHTER was traveling south east along West Strand Street when he encountered a broken, cracked, uneven and depressed portion of the sidewalk. As a result of said broken, cracked, uneven and depressed portion of the sidewalk, Claimant was caused to lose control of his balance and was violently precipitated to the ground.
- 4. Claimant, JONATHAN SCHACHTER, sustained severe permanent personal injuries, including but not limited to a compound fracture of the right ring finger which required emergency surgery and other as yet undetermined injuries, the full extent of which are as yet not fully known. Claims are being made for personal injuries, hospital, physician and other medical expenses, pain and suffering, loss of quality and/or enjoyment of life, and all other damages to which claimants is entitled to by case law and statute.

As a result of the foregoing, claimant has been damaged in a sum of money commensurate with her injuries, which exceeds the jurisdiction of all lower Courts, together with the costs and disbursements of this action.


