Fair Street Ext Public Hearing

Dear Members of the Common Council,

Upon review of project information provided by the City of Kingston on its website, I would like to comment regarding the proposed partial abandonment of the Fair Street Extension to facilitate the Kingstonian development project.

In the project's SEQR EAF form on page two under Government Approvals, it is noted that the Council has to approve "Sale or Lease of Land/Closing of Fair Street Ext."

The land (parking lot) has **NOT** been sold/leased by the City on behalf of its constituents, but instead has been conveyed to the Kingston Local Development Corporation (KLDC). According to Mayor Noble, the KLDC has entered into a land development agreement to convey this public land to the Kingstonian for-profit development, but the details of this agreement have not been publicly posted for review. This transaction, in my opinion, is a violation of the public trust.

The Mayor's public comment states that you are not being asked to transfer the property of Fair Street Ext to the Kingstonian and that the City will retain ownership for a new public use. This use as stated by the Mayor will include a public plaza and public restrooms, all of which will require regular maintenance.

Interestingly, Mayoral correspondence to Council President Shaut dated Oct 1, 2021 and Finance Committee Report wording both call for the Kingstonian development to agree to be responsible for all maintenance of Fair Street Ext (presumably this includes the plaza and restrooms) in order to receive an easement. However, the proposed Council resolution authorizing partial abandonment of Fair Street Ext does **NOT** include this language or make any reference to it. Is this authorization to be handled separately? What is the correct process for it and how will the public be informed?

Given the City's failure to formally document anything in the public interest with this developer and its general lack of coherent process to date (which should include straightforward disclosure to the public), I hope that the Council pays close attention to what it is signing off on. Please do not continue to violate the public trust by failing to ensure that the Kingstonian's responsibilities are clearly outlined if there is to be an exchange of publicly owned land. And please do the research to ensure that this exchange is being conducted in a fully legal manner, without being rushed through to accommodate development interests at the public's expense.

I'm very much in favor of new-urbanism style adaptive reuse of space. I walk around the Stockade district every day, and I drive only rarely. I think the Kingstonian is, overall, an excellent project.

But looking at the road from a practical level: Fair street is a major avenue to get to/from the shopping plaza. Because of the railroad tracks, there really aren't many ways to get to/from the shopping plaza area.

I think it would be wise if the city were to close off the street for a week or two as a test-run, and determine what kind of impacts this would have. I think it could be a great win for our city, but it could have other side-effects that may not be anticipated (ex, traffic routed through smaller historic streets).

Dear Clerk and Council Members,

I was disappointed by the myriad of technical problems and delays during the Public Hearing on December 2 regarding the proposed "abandonment" of Fair Street. Given the continuous problems, it would have been appropriate to reschedule the hearing as members of the public may not have had adequate chance to be heard if they were unable to stay through all the delays. It also seems contrary to the interest of the public and transparency to have moved up the hearing from December 9 to December 2. If there was a scheduling conflict, it would have been prudent to delay rather than move up the date to allow for people to adjust their schedules to attend.

As I disclosed during the public hearing, I'm an employee of Langan Engineering, the consulting firm that prepared the traffic peer review memo for the counsel of William Gottlieb Real Estate, in relation to the closure of Fair St Ext. I am not commenting on behalf of Langan or William Gottlieb Real Estate, but in my own interest as a City of Kingston resident and tax payer.

Taking a mapped street away from the public by any mechanism is cause for concern, but the timing in this case is even more troublesome. Not only would the people lose utility of the street, its closure would advance a proposed development that is much larger in scale than anything else within the historic Stockade District. The city has invested \$500,000 of tax payer money for comprehensive, code-based zoning for the whole city. During the November 11 Progress Presentation, Dover, Khol, & Partner's discussed several "big ideas" to inform the new zoning code after collaboration with city residents in a series of community engagement events. Included in these core concepts were the following:

- small scale, as-of right developments
- relationship of buildings to streets and surrounding buildings
- reevaluating how much parking we really need, and
- improved public transport, walkability, and more complete streets

The progress presentation also highlighted the importance of maintaining small block size and avoiding street closures.

Closing Fair Street Extension at this time would be a disservice to the tax payers' investment in rezoning. The closure is an incremental step of a much larger development program and both the street closure and project it would support appear contrary to several
