07/17/2021 21:16 -- Tinti, Elmo (255) -- On 07/17/2021 at approximately 2100 hours while in marked patrol unit 125, I was dispatched to the intersection of McEntee and Hudson Street for a vehicle that had just hit an open manhole. Upon arrival I spoke to Mr. Laselies Hylton, who stated that he was driving down McEntee Street and did not see the open manhole due to the heavy rain. Mr. Hylton's vehicle then popped its rear driver's side tire as a result of hitting the open manhole. Mr. Hylton stated that he had a friend on the way to assist with changing the tire on his vehicle. I replaced the open manhole cover(s) and awaited for Mr. Hylton's friend to arrive before I left the scene. Mr. Hylton to leave his vehicle at the intersection of McEntee and Ravine Street for the evening.
