My daughter attends Edson, and like many families in our neighborhood, we walk to and from school daily. Having a sidewalk on Merilina from Vorhees up would be amazing- but please also consider extending it farther as many children come in from blocks beyond there, ourselves included.

Unfortunately, the lack of sidewalks in this area creates unsafe conditions for children, especially during busy drop-off and pick-up times. I've personally almost been hit by both cars and buses, I've had to hastily move my child and myself onto a neighbors lawn to avoid being clipped by cars and buses, and I've witnessed many other parents experience near misses. It is worse in the winter due to snow pile build up. I'm very happy to know of an upcoming survey for sidewalk placement.

I would, however, like to add that although the traffic is certainly very congested and unsafe between the school and Voorhees Ave., it would be most beneficial to have a survey conducted and sidewalk built from the school down to Boulder Ave.

Many parents are now opting to drive their children to school and in an effort to avoid the congestion and traffic that takes place at the school during the busy drop off and pick up hours, they park farther down on Merilina Ave. and walk their children up the street - therefore limiting the amount of walking area on either side of Merilina Ave. I've witnessed some even parking on my block of Merilina Ave. between Merritt Ave. and Boulder Ave. although I will say that is less common.

I am a parent of two children - one at Edson, and one entering Bailey in the fall. I am writing in strong support for the proposed sidewalk addition on Merilina Ave. leading up to the schools' entrance.

We live too close to the school to be offered busing. We therefore (happily, because it's great exercise and far more eco-friendly!) walk to school every day, crossing busy Lucas Avenue and weaving our way through the residential streets surrounding Edson and Bailey schools (none of which have sidewalks). Every day my first grader and I navigate buses and traffic congestion particularly on the narrow, curved stretch of Merilena Ave leading up to the school; every day we come mere inches from these vehicles, and when it's snowy or icy, even closer. If it's garbage/recycling collection day, we have to weave around bins -- I even had a bin knocked over onto me by a car's side mirror once, such is the close proximity of the passing cars!
