Illona Ross - heard a lot of Poppy Cock from Aker - red herrings for Council

June Nemon – member of Council misrepresented – spoke to a lawyer – wide variety of problems – tenants will have to figure out later – have not reviewed with housing attorney Regulatory Agreement

Roger Gaghoo - live at Stony Run - Stony Run has 266 units that will be affected by this

Eric Jarman – proposed amendments our lawyer provided – live at Stony Run for 3 years and member of Tenants Union

Teresa Greene – has been in Stony Run since 2005 – power is wielded by Council and Mayor – this is an operating dictatorship
