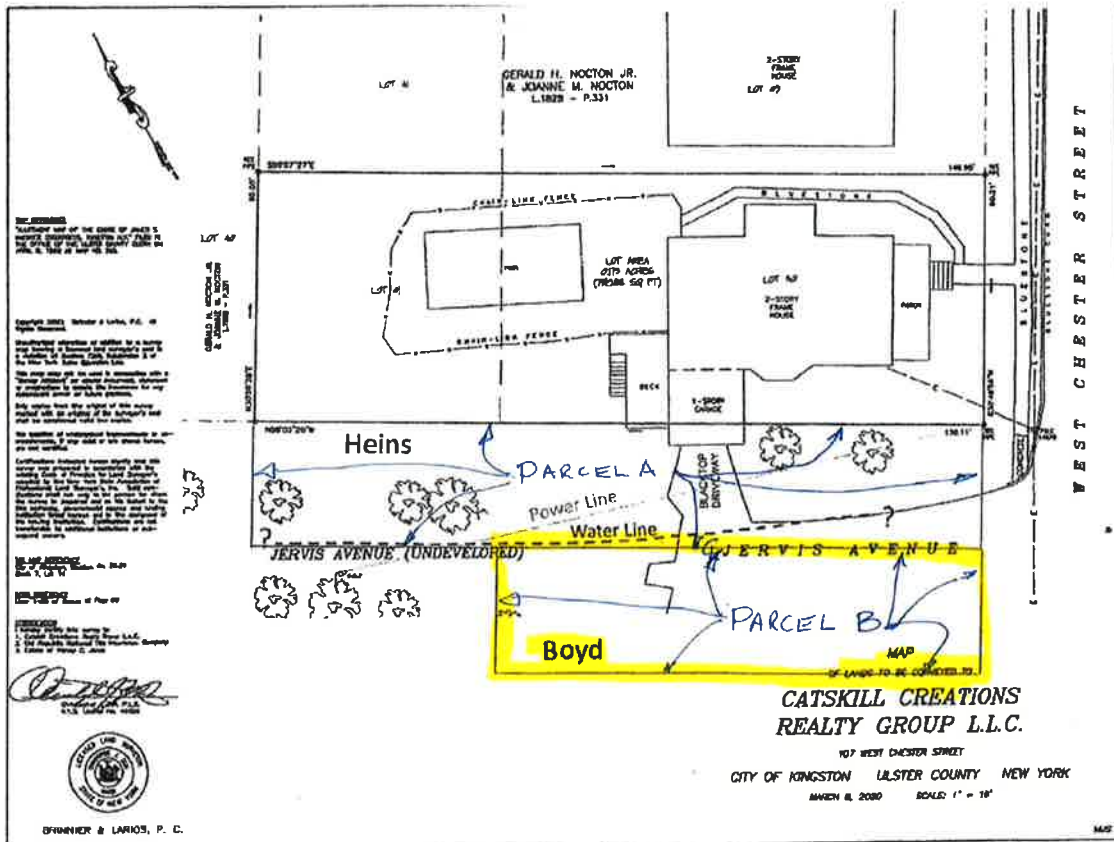

Dear Madam President:

As requested I have completed the Determination of Value analysis of the above referenced property in accordance with the City of Kingston Code. In order to determine the value this Jervis St. section it was first necessary to determine the current market value of the property and then apply the valuation standards set forth in the City of Kingston Code. The City of Kingston Code requires that in determining the "price", the assessor shall consider "the reuse of the parcel for which it lends itself" and "the quality of the title".

The following assumptions are made in determining the value of the street:

- 1) The reuse of the property will be a used as a side yard/driveway and NOT as a separate developable piece of land.
- 2) The quality of the title will be "good, clear and marketable title"

This "Determination of Value" report sets forth the pertinent data gathered, the valuation technique used and reasoning leading to the determination of value in accordance with the City of Kingston Code.

It is my conclusion that value to the City of Kingston of the fee simple interest of the subject property (Property known as Jervis St (about 2,500 sqft+- or 0.057 Acres +-) adjacent to property owned by Boyd (SBL# 56.34-7-20)) described by City Engineer John Schultheis in the attached Schedule B with the assumptions as directed by the City of Kingston Code is:

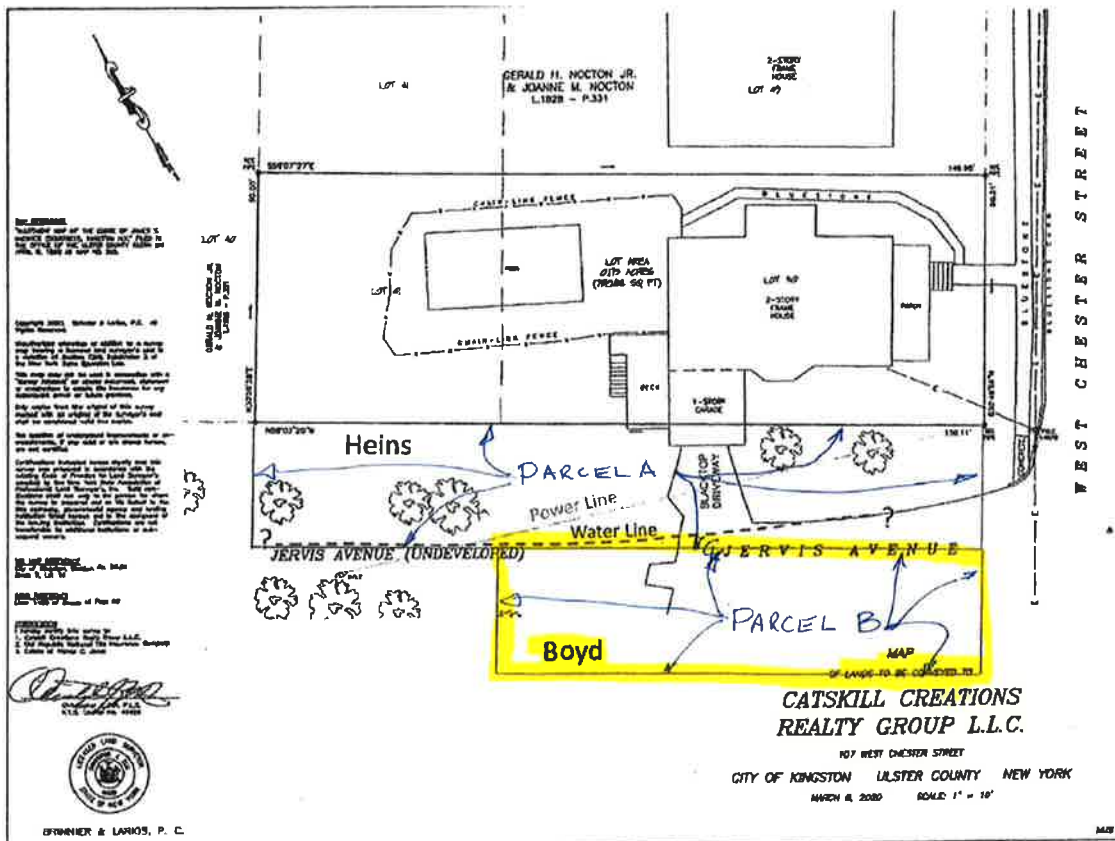

Dear President Shaut,

Please accept this message as a communication to be placed on the agenda of the appropriate committee.

Below is a request from Rob Bielunas, the Regional Director of the Coalition Against Bigger Trucks, asking the Common Council/City of Kingston to send letters to our Congressional representatives asking them—as Mr. Bielunas suggested to me—"to consider opposing any bills or proposals that seek to increase truck weights. Such an increase would place an undue burden on our already strained infrastructure, compromise public safety, and harm the economic vitality of our city." The Police Chief of Saugerties has already sent such a letter on behalf of Saugerties. A copy of his letter and other sample letters are attached.

Apparently there are currently bills before the House and Senate that would increase the weights of trucks on roadways across the country to 90,000 pounds, which can damage existing roadways and bridges and cause increased fatalities in crashes—which is why the request is being made now.

I have a packet of information provided to me by Mr. Bielunas that I can share with you and the committee.

FYI: I suggested to Mr. Bielunas that he also approach the Mayor's Office.


I am writing to ask that you oppose any proposals allowing heavier or longer trucks in the upcoming supply chain markup in the Transportation and Infrastructure Committee.

It is my understanding that on May 23rd, the House Transportation and Infrastructure (T&I) Committee, which I believe you are a member of, will vote on bills dealing with supply-chain issues. Included, I am being told there could be language that would allow a 91,000-pound pilot project on interstates (H.R. 471, Section 8) and increased weights for log trucks (H.R. 2493) and auto-haulers (H.R. 2948). Further, I am hearing that it is possible there will be a proposal for longer "Double 33" trucks also on the agenda.

We are committed here in New York State, to make every effort toward ensuring our public roadways are safe for everyone who travels on them. I am asking that you please vote no on these proposals, as I know you too, value the safety of all motorists, as I do. It is clear from the research, that these proposals, if passed, will negatively affect the safety of all motorists.




