#### **RESOLUTION - OF 2024**

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF KINGSTON, NY, REFERRING TO THE HISTORIC LANDMARKS PRESERVATION COMMISSION, THE KINGSTON PLANNING BOARD AND THE ULSTER COUNTY PLANNING BOARD A PROPOSAL TO AMEND SECTION 405.19 OF THE CITY OF KINGSTON ZONING CODE

**WHEREAS,** a request has been made to amend Section 405.19 of the City of Kingston Zoning Code; and

**WHEREAS**, a request has also been made to refer to the Historic Landmarks Preservation Commission, the Kingston Planning Board and the Ulster County Planning Board a proposal to amend Section 405.19 of the City of Kingston Zoning Code.

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF KINGSTON, NY AS FOLLOWS:

**SECTION 1.** That the Common Council of the City of Kingston refers the following proposed amendments to Section 405.19 of the City of Kingston Code to the Historic Landmarks Preservation Commission for Commission, the City of Kingston Planning Board and the Ulster County Planning Board for comments:

1. Amending Section 405.19 (1) (a) Table 405.19 (d) as follows:

Affordable Housing Unit: A household whose aggregate gross annual income, including the total of all current annual income of members residing in the household from any source whatsoever at the time of application (excluding the earnings of working household members of 21 years of age or younger who are full-time students, does not exceed 50% of the Area Median Income for the actual size of the household (based on the United States Census and as updated by the Department of Housing and Urban Development (HUD), and which household can afford the maximum rent specified in Table 405.19.

Workforce Housing Unit: A household whose aggregate gross annual income, including the total of all current annual income of members residing in the household from any source whatsoever at the time of application (excluding the earnings of working household members of 21 years of age or younger who are

full-time students, does not exceed 80% of the Area Median Income for the actual size of the household (based on the United States Census and as updated by the Department of Housing and Urban Development (HUD), and which household can afford the maximum rent specified in Table 405.19.

### **SECTION 2.** This resolution shall take effect immediately.
